The reasons for fall in Adani stocks could be attributed to the news report published by The Ken captioned "The Adani Group wants you to believe it has repaid all its loans against promoters. Here's why you should not" on its website i.e. https://the-ken.com during pre-market hours on March 28, 2023. The stock price of Adani Enterprises Limited ("Company" or "AEL") fell upto 7.35% with stocks of other listed Adani group companies.

The Company, vide its letter dated March 28, 2023, clarified and refuted the false narrative on repayment of loans against shares published by The Ken. Basis the clarification so issued by the Company, share price of AEL today has gained to its original level (opening position) as of March 28, 2023. The Ken, also (at 3:30 p.m. today) released its update on the original news report published which now reads as "The Adani Group repaid its loans against promoters' shares. But the disclosures don't add up".

NSE vide its letter no. NSE/CM/Surveillance/12903, dated March 29, 2023 advised the Company to take up the matter with editor of the said newspaper / newswire since the news items published by The Ken were at variance with the factual position clarified by the Company.

In the light of the above, we request the stock exchanges to take appropriate actions against such agencies whose actions are prejudicial to the interests of the investors at large.
